

**DRAFT NOTICE OF AMENDMENT TO TOWN OF CHARLOTTE  
MOTOR VEHICLE AND TRAFFIC REGULATION ORDINANCE**

The Selectboard of the Town of Charlotte does hereby ordain:

Pursuant to 23 V.S.A. §1007 and 24 V.S.A. §1976, the Motor Vehicle and Traffic Regulation Ordinance adopted September 22, 1980, and as amended on September 11, 2000, February 11, 2002, June 15, 2009, April 11, 2011, November 14, 2011, April 22, 2013, April 14, 2014, September 9, 2019, and October 4, 2022 is hereby amended as follows:

Section(s) 1(C)(3) and 1(C)(4) of said Ordinance is added so that Section(s) 1(C)(3) and 1(C)(4) states as follows:

(C) A maximum speed limit of twenty-five (35) miles per hour:

3. On Ferry Road from the intersection with Greenbush Road extending in a westerly direction a distance of .4 miles.

4. On all unpaved Class III Town Highways except as otherwise provided in this Ordinance.

Section(s) 1(D)(1) and 1(D)(2) of said Ordinance is amended, and Section 1(D)(3) of said Ordinance is stricken, so that Section(s) 1(D)(1) and 1(D)(2) state as follows:

(D) A maximum speed of forty (40) miles per hour:

1. On Mount Philo Road from a point that is 0.2 miles north of the intersection with State Park Road, extending southerly to the Charlotte/Ferrisburg Town Line.

2. On Church Hill Road from the intersection of U.S. Route 7 extending southerly to the intersection with Hinesburg Road.
